The City receives funding from HUD through the Community Development Block Grant Program and Home Partnerships Program. The City uses this funding to address the housing, community development and human services needs of low- to moderate-income citizens, including persons with special needs (e.g., elderly, physical and mental disabilities, substance abuse, etc.)

As part of its Consolidated Plan planning process, the City is soliciting input from residents and other interested parties in identifying the City's housing, community development and human services needs. Your participation in the planning process will enable the City to develop appropriate strategies to address its priority needs. The City has hired Mullin & Lonergan Associates to assist with the preparation of the Consolidated Plan and the Annual Action Plan.
