Case 1:

Complainant contacted the office because she believes she was discriminated against for her race-African American. Specifically, the Complainant contacted the office after she was terminated from employment due to her supervisor fabricating allegations. The claims came shortly after the Complainant reported racial harassment by the supervisor to Human Resources. Referred to PHRC for lack of jurisdiction. Business is located outside of city limits.

Case 2:

Complainant contacted the office because she believes she was discriminated against for her race- African American. Specifically, the Complainant contacted the office when she was terminated from her employment after a confrontation with a co-worker. The co-worker, Caucasian female, and the Complainant became verbally aggressive towards each other. The Complainant was asked to leave the premises and the co-worker was allowed to continue her shift. Referred to PHRC for lack of jurisdiction. Business is located outside of city limits.
