Non-Jurisdictional Briefs

July

Case 1:

Complainant contacted the office because he believes he was discriminated against for his sex-male. Specifically, the Complainant was terminated from employment after leaving the premises without permission. Complainant claims female employees leave the premises without permission and are not reprimanded. Complainant believes he was discriminated against because he is a male employed in a female dominated business. Referred to PHRC for lack of jurisdiction. Business is located outside of city limits.

August

Case 1:

Complainant contacted the office because she believes she was discriminated against for his disability. Specifically, the Complainant was laid off after requesting an accommodation for her disability. The Respondent hired another person with the same title and responsibilities to replace the Complainant. Referred to PHRC for lack of jurisdiction. Business is located outside of city limits.

Case 2:

Complainant contacted the office because she believes she was discriminated against for her sexual orientation. Specifically, the Complainant reported to HR that she was denied an opportunity to apply for a Team Lead position because the Supervisor stated she "was too distracted by her female co-workers." The Supervisor also made several rude comments to Complainant about talking to the female employees. Referred to PHRC for lack of jurisdiction. Business is located outside of city limits.
