CALL TO ORDER: President Washington called the June 4, 2024, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Elizabeth Bupp, Teresa Johnescu, Felicia Dennis, Betsy Buckingham, Vice President, and Edquina Washington, President, with President Washington presiding.

Members of the Administration included: Kim Robertson, Business Administrator; Dave Rudolph, Electrical Supervisor; Michael Shanabrook and Chris Grove, Emergency Management; and Brett Flower, Assistant Solicitor.

Council staff in attendance included: Dianna L. Thompson, City Clerk.

- II. Called Legislative Meeting to Order at 6:00 p.m.
- III. Roll Call
- IV. Pledge of Allegiance was recited.
- V. Moment of Silence was observed.
- VI. Action on previous meeting Minutes of May 21, 2024 (legislative); May 29, 2024 (committee). Council dispensed with the reading of the minutes and unanimously approved them as written.
- VII. Presentations, Awards and Announcements
  - ▶ Susquehanna Regional Airport Authority (SARAA) Brief presentation by Timothy Edwards, Executive Director, SARAA, with an update on SARAA's operations, current capital projects, and future initiatives.

Timothy Edwards, SARAA Executive Director, and Carolyn VanNewkirk, York City SARAA Board member, were in attendance. Mr. Edwards outlined the role of SARAA and the areas they serve. He said they have a 15-member board and outlined all counties that are represented on the board. He

said Harrisburg International Airport (HIA) has four airlines going to 16 destinations with several connectivity points. In 2023, they had their 3<sup>rd</sup> consecutive year of growth with 2019 being their biggest year. Mr. Edwards said they anticipate 2024 is going to be a good year with increased activity over the summer months. He then outlined various capital projects. He said they found PFAS chemicals in their water, which they were able to completely eradicate. They also did an expansion of their cargo complex which was a \$64 million project. They have three general aviation airports: Capitol City Airport, Gettysburg Regional Airport, and Franklin County Regional Airport. Upcoming events include their 2025 air show on Memorial Day weekend. They secured the Blue Angels to headline the show. There will be static displays and vintage aircraft. He thanked Council for their support in appointing Jim Gross and Carolyn VanNewkirk as York City's representatives on the board. He said Transportation Secretary Buttigieg visited their airport today because they received two significant grants through the transportation program, which includes passenger boarding bridges where they received a multi-million dollar grant to replace those bridges with six new bridges.

Councilwoman Johnescu asked to pull agenda items 5, 8, 9 & 10 from the consent agenda.

**Motion to consider consent agenda items:** A motion was made by Washington, seconded by Dennis, to consider agenda items: 4, 6, 7, and 11-13 as a consent agenda. The motion passed by the following vote: Yeas – Bupp, Johnescu, Dennis, Buckingham, Washington – 5; Nays – 0.

President Washington asked if there was any Council, Administration or public comment on the consent agenda items. There was none.

Motion to approve consent agenda items: A motion to approve agenda items 4, 6, 7, and 11-13, was made by Washington, seconded by Dennis, and passed by the following vote: Yeas - Bupp, Johnescu, Dennis, Buckingham, Washington - 5; Nays - 0.

Resolution No. 51, Session 2024, A Resolution exonerating municipal taxes and penalties for Children's Aid Society in the amount of \$3,422.82, was introduced by Buckingham, read at length, and on motion of Buckingham, seconded by Dennis, Resolution No. 51 came up for discussion.

Councilwoman Johnescu said she followed the conversation from Treasurer Jefcoat on this request. She said the real estate was transferred in November 2022, it is not grandfathered, and they have to meet the requirements to have the property exonerated. She said we need a policy in place on how to consider these exonerations. She said this seems to be the business of dealing with 501(c)(3) entities. If we approve these without some policy in place, this puts us in a bad position. She said she is concerned about our senior citizens who has to take the brunt of these exonerations.

Solicitor Flowers said we get this with charities where they buy a property and then don't realize they need to go to the York County Board of Assessment and Appeals to get the exception. She said the question of forgiveness is different from whether they are entitled to an exemption. She said this property was historically tax exempt.

Vice President Buckingham said a representative was here for our committee meeting and thoroughly explained the request, but she agreed that we need a standard established for forgiveness or denial.

Councilwoman Johnescu said there is no hardship and they had to reapply for the exemption.

President Washington said she agrees that we need some policies and procedures in place to follow when it comes to these exoneration requests because she feels there could be an onslaught of these organizations coming to Council.

There being no further discussion, Resolution No. 51 PASSED by the following vote: Yeas - Bupp, Dennis, Buckingham, Washington - 4; Nays - Johnescu - 1.

Resolution No. 54, Session 2024, A Resolution authorizing an agreement with Wireless CCTV, LLC in the amount of \$132,077.47 for the purchase of three (3) security surveillance towers, was introduced by Washington, read at length, and on motion of Washington, seconded by Buckingham, Resolution No. 54 came up for discussion.

Councilwoman Johnescu thanked WellSpan Health for making this possible. She said these cameras are intended to be a tool for the Police Dept. and are very visible and can be deployed for various events or high crime areas. She said they will serve as an extra set of eyes and will be deployed in public places. She said a policy for the use of these cameras is a good idea, and if the cameras work and helps to reduce crime, it's a plus.

Councilwoman Bupp said she agrees, and she feels the police department should draft a policy on usage and how they will handle the footage of those cameras.

There being no further discussion, Resolution No. 54 PASSED by the following vote: Yeas - Bupp, Johnescu, Buckingham, Washington - 4; Nays - Dennis - 1.

### 9. Resolution No. 55

Resolution No. 55, Session 2024, A Resolution authorizing a budget transfer of ARPA funds in the amount of \$50,000.00 for the GVI & Credible Messenger Program to identify funds for Client Services, was introduced by Washington, read at length, and on motion of Washington, seconded by Johnescu, Resolution No. 55 came up for discussion.

Councilwoman Johnescu said after hearing the frustration of residents about ARPA distributions and difficulty understanding the ARPA dashboard, she feels this could affects transparency. She said this money going toward GVI initiatives is a good idea if it meets the safety and security needs of our residents. She stated that she just wants to make sure residents understand what these funds are being used for.

President Washington said these will be used to protect and provide for our residents. For example, they will be used for personal safety relocation efforts, diapers for needy families, bus fare so individuals can go to work or to the grocery store, as well as other items that are not readily available to some residents.

Councilwoman Bupp said the GVI meetings are open to the public and they accept donations.

Marie Rohleder, resident, said everything said is moot because there isn't a strategic plan in place and that everything should come from whatever the strategic plan says. She said the ARPA dashboard is impossible to understand. She asked where the strategic plan is that guides you on how to spend this money. She said she has no problem with what Council is doing but not having direction is what disturbs her. She said she was part of the committee to recommend ARPA funds but that was tossed to the wayside.

President Washington said Council does have a strategic plan and we can assist you in locating that online. We also have our ARPA consultants, ANSER, who guides us and makes sure expenditures are being spent properly. She said we are working on the website to make the ARPA dashboard more user friendly, but this takes time.

Councilwoman Johnescu asked if Ms. Rohleder was talking about the comprehensive plan. Ms. Rohleder said, yes. Councilwoman Johnescu said that is separate from ARPA, but the Planning Commission has been working through a long process in the comprehensive planning process and it is in the final stages.

Vice President Buckingham said regulations must be strictly followed when allocating ARPA funds, which is outside of the comprehensive plan, and our ARPA consultants are there to tell us what funding can and cannot be spent on.

Councilwoman Bupp said the comprehensive plan is available for review June 11 & 12 and will be open for public discussion. She said the information was posted on the city's website by Jada Richardson.

There being no further discussion, Resolution No. 55 PASSED by the following vote: Yeas – Bupp, Johnescu, Dennis, Buckingham, Washington – 5; Nays – 0.

#### 10. Resolution No. 56

Resolution No. 56, Session 2024, A Resolution authorizing agreements with the York City School District and All City Management for crossing guard services for the 2024-2025 school year, was introduced by Buckingham, read at length, and on motion of Buckingham, seconded by Washington, Resolution No. 56 came up for discussion.

Councilwoman Johnescu said she is still concerned because this company is located out of California. She said she realizes we split the funding for this service with the school district, but she wants to see a breakdown of the expenses and questions whether this is cost effective. She asked what metrics are being used and feels this is very vague and we are operating blind in this process.

Councilwoman Bupp said she was looking at the employment page on the city's website and under the police department there is a crossing guard position, and it says to All City Management at a \$12 rate.

Councilwoman Johnescu said we are paying All City Management more than \$28 per employee.

Vice President Buckingham said that cost also includes liability and other expenses.

**Motion to abstain:** Councilwoman Dennis asked to abstain as she is employed by the York City School District. The motion to abstain was approved unanimously.

There being no further discussion, Resolution No. 56 FAILED by the following vote: Yeas - Buckingham, Washington - 2; Nay - Bupp, Johnescu - 2; Abstain - Dennis - 1.

Since there were not at least 3 votes to approve, Resolution No. 56 did not pass.
