The United States is facing a crisis in primary care; over 100 million Americans face some primary care access barriers.

York County Health Metrics

The following health indicators underscore the

importance of health care to York.

- **27%** No routine check-up in last 12-months.
- **25%** No dentist check-up in last 12-months.
- **37%** No physical exercise in the last month.

65% One or more days with depression in last two weeks

- **44%** Stressed about money
- 73% BMI: Overweight or Obese

The above metrics point to a community that is struggling to thrive with a high propensity for chronic illness.

PRIMARY HEALTH CARE PROVIDER (PCP)

A Primary Health Care Provider is the first point of contact for people seeking medical care, such as a family doctor. Access to primary care health services is fundamental for the overall well-being and vitality of a community; providers serve as the cornerstone of the city's healthcare system.

- Continue and increase the distribution of educational materials regarding the dangers of lead contamination. Tier 1
- Partner with local medical professionals to be role models who can act as intermediaries between the public and the health services field. Tier 1
- Promote the educational and training materials available to health service workers to reduce discrimination and biases towards patients. Tier 2
- In collaboration with YCEA, WellSpan Health, UPMC, and the County of York, explore training and scholarship programs that offer education loan forgiveness, scholarships, and incentives to medical students and residents who commit to practicing primary care in underserved areas. Tier 1
- Partner with local medical facilities to create a "reward" program that incentivizes patients to complete welfare appointments on a regular basis. Tier 2
- Work with local community leaders to create and expand peer support groups throughout the city.

- Partner with WellSpan Health and UPMC to create workforce housing initiatives for healthcare workers and providers. Tier 2
- Assist residents with soil testing to prevent lead contamination in homegrown produce and/or provide resources to assist residents with creating raised planting beds. Tier 2
- Create a health assistance fund for residents struggling to cover the copay on rendered health services. Tier 3
- Create and maintain a case management system for those struggling with covering the costs associated with services.
