CALL TO ORDER: President Washington called the July 16, 2024, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Elizabeth Bupp, Teresa Johnescu, Felicia Dennis, Betsy Buckingham, Vice President, and Edquina Washington, President, with President Washington presiding.

Members of the Administration included: Kim Robertson, Business Administrator; India Banks, Interim Director of Public Works; Dave Rudolph, Interim Director of Public Works; Deputy Fire Chief Adam Smith; Keith Gerber, Highway Superintendent; and Gedd Schweikert, Assistant Solicitor.

I. Public Comment called to order at 6:00 p.m.

Don Hake, resident, read a resolution from the September 17, 2019 Council meeting, where Council said they would join other communities in the effort for clean, renewable energy sources. Councilwoman Johnescu asked for an overview of the project.

Jeff Stough, Warehaus, explained that the property has two addresses. This is a 3.2-acre parcel west of the Dentsply building. He said they're just talking about the little parking lot next to the park. He said we don't plan on subdividing any land or putting up any new buildings. This is just for additional parking and that they will submit a stormwater plan and will meet the requirements of the subdivision/land development ordinances.

Councilwoman Johnescu asked if motor vehicle services is another term for parking. Mr. Stough said, yes.

Councilwoman Bupp said she looked up the zoning ordinance relating to dimensions and the table in Article 1303.14 of the codified ordinances talks about keeping 20% of the property pervious so she said she assumes they'll adhere to that.

Mr. Stough said yes. The property goes down to the creek.

Don Hake, resident, said he would like that it's required that it be LEED certified and renewable energy introduced into this, which would be a great start for us.

Tom Englerth, Site Design Concepts, said on the blue side of the plan is the existing conditions. The RDA owns these properties. The one parcel had property that was demolished. We are proposing a 4-lot subdivision. There will be 2 lots facing Cottage Hill Rd. and 2 on the rear on Union. The setbacks will be on the external of those duplexes on these lots. This is a unique project in that the developer has signed an agreement with the RDA for building these duplexes in a small footprint and will be attainable for residents that want to buy them. The intention is not to rent.

Councilwoman Johnescu said the subdivision is just up for approval tonight. Mr. Englerth said this is just for the subdivision.

Councilwoman Bupp said if we approval this, does the approval stay with the land or the developer. Council responded it's just the land.

Marily Hake, resident, said they will be about 600 sq. ft. and she's a proponent of small homes, but she didn't think homes could be built under 700 sq. ft. She said the law should be changed to allow this square footage to be smaller.

Mr. Englerth said he misspoke and that whatever minimum is allowed, that's what they'll be building unless they want to go smaller and if so, they will ask for a variance.

Don Hake, resident, also asked for renewable energy for this project.

Councilwoman Bupp thanked the York County Planning Commission for their review comments. She said that Article 1303.10 of the zoning ordinance has the dimensional requirements.

Keith Gerber, Highway Superintendent, said they are asking to purchase a new leaf vac. We are at the end of life of two of them which are from the early 2000's. We would like this one to stay up with the leaves this coming fall.

Councilwoman Bupp asked how this purchase is funded and why the five-year lease and how much extra to finance it.

Administrator Robertson said this is being funded through liquid fuels funding from the state. We get \$1.1 million which must be split across various expenses that we are allowed to use these funds for such as snow removal, which is our biggest expense, repairs to storm sewer drains, street resurfacing, traffic signals, street cleaning and signage. Every year, we are told how much we'll get, and we allocate those funds out. We will be at \$12,281.50 in interest over the five years and then a \$1 lease buy-out.

Vice President Buckingham said so the lease will be paid with the liquid fuel funds and the interest will be absolved in that as well. Administrator Robertson said yes.

Keith Gerber, Highway Superintendent, said this is their annual paving project. This year we are asking for this amount to pave 11 separate projects for various neighborhoods throughout the city. Some of the money goes toward improving the ADA ramps. This is part of our 5-year plan. We planned for 13 projects but had to cut two because of funding restrictions.

Councilwoman Bupp said the lower bid was picked for these projects and she appreciates that this procedure was followed.

Dave Rudolph, Interim Public Works Director, said this is paid through an ARLE grant that we get through Philadelphia's revenue from their red-light enforcement program. This includes flashing lights at the crosswalks, new stripping, and narrow lanes. The biggest project will be Philadelphia St. and Roosevelt Ave. to make one direction of travel moving at one time, along with ADA corners and installation of bollards.

Councilwoman Buckingham said the issue with this that people who are in the turning lane on Penn St. end up going straight, which is a big problem.

Director Rudolph said northbound and westbound traffic will move on its own then southbound then eastbound traffic will move.

Don Hake, resident, asked if this has been found to be a high accident area. Director Rudolph said yes.

Business Administrator Robertson said this is for the police, fire, and parking enforcement all of which is tied back to the county 911 system. We must use the radios that the County sets up their system for. The current radios are not being manufactured anymore, so we need all new radios. Staff reached at to emergency services and since we can buy in bulk, we save costs.

Administrator Robertson said we were approved for six vacancies but were only able to hire five because the eligibility list expired. So, this is the one we didn't get to fill before.

Councilwoman Bupp asked how many firefighters we have. Administrator Robertson said we are up to 70 because we have four positions that are paid via grant, which has increased our total to 70. Councilwoman Bupp asked if there are other fire department staff. Administrator Robertson said besides all the rank personnel and the chiefs, there is one administrative assistant and two part-time emergency coordinators.

Deputy Fire Chief Adam Smith outlined the positions in the Department of Fire/Rescue Services.

There being no further discussion, Resolution No. 67 PASSED by the following vote: Yeas -Bupp, Johnescu, Dennis, Buckingham, Washington - 5; Nays - 0.

Administrator Robertson said at the last meeting the school district and ACMS was combined into one resolution that included this agreement where the school district will reimburse us for 50% of school crossing guard services, and a separate agreement with the actual vendor, ACMS. However, she said, the Resolution didn't pass at that time. She said they split the resolution this time and after speaking with the solicitor's office, Councilwoman Dennis will not have to abstain because there is no conflict. She said the school district has passed this agreement already.

Councilwoman Bupp said she appreciates the extra work and emails relating to this.

Councilwoman Dennis read a statement apologizing for abstaining when this came up for a vote on June 4 because she didn't know she was able to vote because she is employed by the school district. So, she said out of an abundance of caution, she abstained. She stated that she understands the desire to discuss this contract further but until there is a solution, we cannot put our kids in danger because they need a safe passageway to and from school.

There being no further discussion, Resolution No. 69 PASSED by the following vote: Yeas -Bupp, Johnescu, Dennis, Buckingham, Washington - 5; Nays - 0.

Councilwoman Johnescu thanked Administrator Robertson for providing information that wasn't provided before. This is something that York City residents want. My questions are a matter of oversight and accountability-something that City residents expect. Although I expect this to pass, it will pass without my support. I am concerned that the city administration is not receiving regular reports from this vendor who is based in California, and the high cost to the taxpayers. Other concerns are that up to 15% of crossing guards didn't show up, we don't have a name for the person who is responsible for hiring, and we don't get performance reports. It's not enough to delegate our children's safety to a phone number. A York City minority firm stepped up to take this contract, which would be better than a California based company.

Vice President Buckingham said there are two local phone numbers of individuals who manage the crossing guards, and one didn't answer because it's not in season, and the other left a message that detailed information. So, there is local engagement with this contract.

Dennis said she understands Johnescu's concerns but our student's safety is important especially when we can easily get a name. At the June 4 meeting, we already discussed that there is a local contact. She said do we hold that up again when we are one month from start of school.

Councilwoman Bupp said reading through the contract the agreement can be terminated with three weeks' notice, so this gives us an opportunity to reach out to them, but she agrees that we can't hold this up now since school will be starting in a few weeks.

President Washington said we are the legislative branch of government, and the executive branch is who takes care of the everyday functions of the city. It is not our job to reprimand them how they should go about doing certain things, especially since they are capable and are doing a wonderful job.

There being no further discussion, Resolution No. 69 PASSED by the following vote: Yeas - Bupp, Dennis, Buckingham, Washington - 4; Nays - Johnescu - 1.

Administrator Robertson said she was working with Tammy Harvey-Bethea from the BHS and how they have to put together a plan every year. Sometimes that plan changes and this is a request to shift from one bucket to another because there is a need for a different type of service that can be provided for this funding.

Councilwoman Bupp asked if a project has been identified for the \$100K demo fund.

Jada Richardson, Deputy Director of the Bureau of Housing Services (BHS), said RDA receives money from us for stabilization. This money goes into the bucket if there is an emergency demolition for blight remediation.

There being no further discussion, Resolution No. 70 PASSED by the following vote: Yeas - Bupp, Johnescu, Dennis, Buckingham, Washington - 5; Nays - 0.

- XII. Council Comment

Councilwoman Bupp discussed an email about a resident complaining about dirt bikes. She asked about the status of the camera system. She said we are aware of this issue and the York Safety Collaboration is working on the camera system although she doesn't know the status at this time. She said you can reach out to LogosWorks for comment. She then discussed feral cats and the trap, neuter, and release program which is a super program, and she is interested in building a simple committee to discuss options. She then spoke about gas meters in that there is a new type of gas meter, and you can request a smaller gas meter and its placement and the color it will be painted. Next, she said food trucks were discussed at the last meeting and she hopes we can get those answers. Lastly, she said a resident has a child that wants to ride her razor scooter to school and maybe we can install a guardrail and other safety measures. If anyone has suggestions and wants consideration for legislative help, contact her.

Councilwoman Dennis asked that we keep those affected by the huge fire this weekend in their thoughts and prayers.

XIII. Administration Comment

Administrator Robertson gave a shout out to our fire department for how well they handled the large fire this weekend. She said she was nervous and could only imagine what our firefighters must go through. She thanked them for stepping up and doing such a great job. The police department also stepped in and used their drone which was purchased through ARPA funds. It was a huge help. She said all those who stepped up to buy food and drinks for the firefighters are greatly appreciated and Fire Chief Sleeger will publicly acknowledge that.

Councilwoman Bupp thanked the outlying fire departments that came to our aid, and she keeps those in her prayers who were struck while in their vehicle by fire trucks responding to their fire.
